## Teen Court Advisory Board Meeting Minutes - August 13, 2015

Panelist's Interview and Training - Marie gave an update on the Interview process and training.

**Running Statistics –** Annie gave a report on the Teen Court Statistics, also handouts were provided at the meeting.

**School Truancy Meeting-**Judge Duvall gave an update. (State Statue 118.162. Truancy committee and plan once every 4 years, in each county, the school district administrator of the school district which contains the county seat designated under s. 59.05, or his or her designee, shall convene a committee to review and make recommendations to the school boards of all of the school districts in the county on revisions to the school districts' truancy plans under sub. (4m)) On March 6th, Buffalo County Truancy Committee met at the Alma High School. On May 22, the Pepin County Truancy Committee met at the Durand High School.

**Teen Court Resource Hub –** Annie gave a report on the Resource Hub. It has been used by other Teen Courts in the state and has been added to UWEX State listing of professional resources. Specifically the Teen Court Training videos by Dana have been used.

**Wisconsin Teen Court Association (WTCA)** – Marie Ritscher gave an update on the meetings. This year Buffalo-Pepin Teen Court will hosting the Wisconsin Teen Court Conference on October 23 of 2015 in Menomonie. Dana, Annie and Marie have been meeting and working on the details.
