Teen Court Advisory Board Meeting Minutes – February 25, 2015

Meeting started at 11:05 am at the Buffalo and Pepin County Human Services Meeting Rooms (connected via video conferencing)

Welcome and introductions.

Review Minutes from September 30, 2014 – Bill Clouse made a motion to accept the minutes, Duey Bauer 2nd. Motion carried.

Financial/ Fundraising- Gina reported the present balance of \$15,833.94.

- Donation letter was sent out February 16, 2015 and a few donations have come in.
- A copy of the donation letter was presented and the 2014 Annual Report was included in the letter.
- Also presented was a listing of 2013, 2014 and 2015 donations.

Running Statistics – Dana Erickson gave a thorough report on the Teen Court Statistics, also handouts were provided at the meeting.

Video/PSA Teen Court – A copy of the PSA (Public Service Announcement) and 5 minute video/infomercial was sent to all the Teen Court agencies. Duey Bauer stated he used the video/infomercial at a school board meeting and it was well received and that it was a great tool to use for explaining/promoting Teen Court. Judge Duvall and Marie Ritscher both have used it at the county level.

Truancy Meeting Update-Judge Duvall has been in contact with Mr. Sedlemayr, Alma School Administrator, there will be a Buffalo County Truancy meeting, March 6th. Mr. Clouse will contact Mr. Doverspike, Durand School Administrator, to start the process of setting up a Pepin County truancy meeting.

Teen Court Annual Report – Dana Erickson completed the report for 2014 and gave an update on the purpose of the report; it can be used as a resource or teaching tool for Teen Court Agencies.

Panelist Training Mini Session –this year mini sessions included and online videos that panelist could view through the Teen Court Facebook page or Teen Court Resource hub.

Teen Court Resource Hub – the website is up and running.

Wisconsin Teen Court Association (WTCA) – Marie Ritscher gave an update on the meetings. This year Buffalo-Pepin Teen Court will hosting the Wisconsin Teen Court Conference in October of 2015.
